**1.OBJECT OF THE CONTRACT**

**6.RESCISSION OF THE CONTRACT**

The contracted has the faculty to recede from the present Contract by giving written communication through registered letter A/R within the peremptory term of 7 days after the stipulation of the Contract itself.
